The analysis of the scores of the Math portion of the ISTEP+ indicates a weakness in the pass rate for special education students in comparison to general education students in grades 3-6 for the 2014-15 school year. During the 2015 ISTEP+ test, 77.4% of general education students in grades 3-6 passed in comparison to 33.3% of our special education students in grades 3-6.
